## NUVO *Transcendence* Giveaway Official Contest Rules and Regulations.



No purchase or payment of any kind is necessary to enter or win a prize. A subscription will not increase your chances of winning. Void where prohibited. Each entrant agrees to these official rules. Winner will be required to participate in the prize fulfillment process and may have to sign documentation, such as a release, in sponsor's sole discretion as more fully described below, or prize may be forfeited.
